

Proclamation of Freedom

By the President of the United States of America:

A Proclamation.

Whereas, Congress has failed to fulfill its duty to faithfully represent the interests of the American people, and;

Whereas, Congress has passed laws directing the Secretary of the Treasury, through the Commissioner of Internal Revenue, to garnish the wages of American citizens; issue liens and levies against their property; levy fines against them; and imprison them for tax evasion, failure to file income tax returns, pay income taxes, and other alleged violations of the current income tax laws, and;

Whereas, Congress has passed laws directing the Department of Justice to prosecute American citizens for tax evasion, failure to file income tax returns, pay income taxes, and other alleged violations of the current income tax laws, and;

Whereas, the American people have exercised the full power of their vote to restore their freedoms, as granted to them by God and preserved by the Constitution of the United States of America;

Now, therefore I, [NAME], President of the United States, by virtue of the power in me granted by Article 2, Section 2 of the Constitution of the United States of America, which states “*The President... shall have the power to grant reprieves and pardons for offenses against the United States, except in cases of impeachment*” do, on this twentieth day of January, in the year of our Lord [two thousand and ?], and in accordance with my purpose to do so publicly, proclaim the following, to wit:

I hereby pardon, and order the immediate release of, all American citizens currently imprisoned for tax evasion, failure to file income tax returns, pay income taxes, and other alleged violations of the current corporate and individual income tax laws, and;

I hereby remove the threat of prosecution of all American citizens, and businesses, for tax evasion, failure to file income tax returns, pay income taxes, and other alleged violations of the current corporate and individual income tax laws, by directing the Commissioner of Internal Revenue, and all employees of the Internal Revenue Service, to submit letters of resignation from office, and;

I hereby remove the threat of prosecution of all American citizens, and businesses, for tax evasion, failure to file income tax returns, pay income taxes, and other alleged violations of the current corporate and individual income tax laws, by directing the Attorney General, all United States Attorneys, and all Assistant United States Attorneys to submit letters of resignation from office, and;

I hereby encourage all American citizens to contact their elected representatives and demand that they repeal all of the laws set forth in the Economic Freedom Act and set in motion a Constitutional Convention to repeal the 16th Amendment, which states:

“The Congress shall have power to lay and collect taxes on incomes, from whatever source derived, without apportionment among the several states, and without regard to any census or enumeration.”

With the threat of prosecution removed, I hereby set free all American citizens, and businesses, to arrange their finances to stop all federal withholding from their wages and salaries, stop all income tax payments to the U.S. Treasury, and restore 100% of their money to spend, save, invest, and donate to charitable causes, as they choose, in a manner that results in personal responsibility, self-determination, and freedom from Government interference, in recognition of the unalienable Rights of Life, Liberty, and the pursuit of Happiness, as set forth in the Declaration of Independence, and, in accordance with the freedoms granted to them by God and preserved by the Constitution of the United States of America.

And upon this act, sincerely believed to be an act of compassion and justice, warranted by the Constitution, upon necessity to restore freedom to all American citizens, I invoke the considerate judgment of mankind, and the gracious favor of Almighty God.

In witness whereof, I have hereunto set my hand and caused the seal of the United States to be affixed.
